### 2. Hazards identification

### 4. First aid measures

**Eye contact** Check for and remove any contact lenses. Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical attention immediately.

**Skin contact** In case of contact, immediately flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse. Clean shoes thoroughly before reuse. Get medical attention immediately.

**Inhalation** Move exposed person to fresh air. Loosen tight clothing such as a collar, tie, belt or waistband. Get medical attention immediately.

**Ingestion** Wash out mouth with water. Do not induce vomiting unless directed to do so by medical personnel. Get medical attention immediately.

**Protection of first-aiders** No action shall be taken involving any personal risk or without suitable training. If it is suspected that fumes are still present, the rescuer should wear an appropriate mask or self-contained breathing apparatus. It may be dangerous to the person providing aid to give mouth-to-mouth resuscitation. Wash contaminated clothing thoroughly with water before removing it, or wear gloves.

**Notes to physician** No specific treatment. Treat symptomatically. Contact poison treatment specialist immediately if large quantities have been ingested or inhaled.

## 5. Fire-fighting measures

<b>Flammability of the product</b>	In a fire or if heated, a pressure increase will occur and the container may burst.
<b>Extinguishing media</b>	
<b>Suitable</b>	Use an extinguishing agent suitable for the surrounding fire.
<b>Special exposure hazards</b>	Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. No action shall be taken involving any personal risk or without suitable training.
<b>Hazardous thermal decomposition products</b>	Decomposition products may include the following materials: carbon dioxide carbon monoxide metal oxide/oxides

## 6. Control and preventive measures

<b>Storage</b>	Store in accordance with local regulations. Store in original container protected from direct sunlight in a dry, cool and well-ventilated area, away from incompatible materials and food and drink. Keep container tightly closed and sealed until ready for use. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabeled containers. Use appropriate containment to avoid environmental contamination.

### Personal protection
